Large National Network of Ambulatory Surgical Centers Doubles Order of STREAMWAY Systems

Skyline Medical's STREAMWAY System is Preferred Fluid Management System for Surgical Centers around the U.S.

This second order comes just a few months after the first order, a testament to the safety, efficacy, and cost-efficient technology of the STREAMWAY System.

This national organization that will be continuing to install the Company's technology creates physician-owned and operated ASCs in partnership with local surgeons and currently has more than 150 centers throughout the U.S.
