## Precision Therapeutics' Skyline Medical Division Expands Presence in Australia with Three New STREAMWAY Systems at Wangaratta Hospital in Victoria

MINNEAPOLIS, Feb. 07, 2019 (GLOBE NEWSWIRE) -- Precision Therapeutics Inc. (NASDAQ: AIPT) ("Precision" or "the Company") today announces its Skyline Medical division, producer of the FDA-approved and CE-marked **STREAMWAY® System** for automated, direct-to-drain medical fluid disposal, has received an order from its Australian distributor for three STREAMWAY system units to be placed in a "center of excellence" in an emerging orthopedic department at Wangaratta Hospital in Victoria, Australia. This installation will demonstrate the system's innovative properties, functionality and cost effectiveness, especially for high volume procedures. The three units are a significant addition to Skyline's presence in Australia and are placed in conjunction with its Australian distributor, Device Technologies, AU (<https://www.device.com.au>).
